Discussion points regarding NCU research initiatives.

#### Background

The Nordic countries has been supporting Nordic cancer research through NCU for a long period of time. Despite some changes in the strategy defining research topics, small changes in the structure of funding has been done. Each year a total of € 750.000 has been awarded to cancer research after evaluation by a scientific committee. For the national membership organizations research funding through NCU is just a small part of their total investment in research.

Relative to the total sum a substantial number of applicants get NCU funding (16 projects in 2016). Probably grants from NCU is often a type of "seed funding" that demands funding from other sources as well. Besides reports from each project we have little knowledge of the long-term effect of NCU funding.

The last couple of year there has been increased interest in Nordic research. Not only in the cancer area but also in other areas. For example, in all Nordic countries there is an intention to increase patient participation in clinical studies. At the same time, we see that each country-relatively speaking - has a small population, but if we manage to recruit patient from all Nordic countries we have a population of roughly 25 million.

In addition: other organizations have made contact with the NCU to examine if there might be possible areas for collaboration regarding research funding. In the last two years we have been contacted by EORTC (European Organisation for Research and Treatment of Cancer), Cancer Research UK, and NORDFORSK.

So fare we have not been able to discuss in depth how we should respond to these different initiatives – and in a way related: what is the future for NCU research funding?

Even if the cancer leagues in the Nordic countries has many similarities there are also obvious differences - how we do our research funding is one of them. And since research funding is one our core activities there are often very clear regulations/rules defining each country's research funding system. As a consequence, making (even small) changes often demands some type of process.

So the aim of this document is to open up for input from each country regarding their stand on possible collaboration with other international stakeholders. Below I have asked each country if they today have other international collaboration besides NCU.

Cancer kostnader i de nordiska länderna – ett nytt projekt initiativ.

Bifogad en bilaga för punkt 10 och här text:

Total cost of cancer is expected to raise mainly due to increasing number of new cancer cases and introduction of new expensive treatments. According a recent study made in Finland the real cost of cancer increased one percent per year between 2009 - 2014. This was less that had been expected. Furthermore, the real cost per new cancer case decreased slightly. It seems that, at least in Finland, the health care system was able to buffer the effects of drivers which increase or tend to increase costs. It would be most useful to find out what is the situation in other Nordic countries and whether there are differences in distribution of costs to direct and indirect costs and, especially, between different categories of direct costs. We have, so far, contacts in Denmark, Finland and Iceland. The purpose is to prepare a proposal of a strategic project to the Board of NCU at its next meeting in February 2018.

#### Funding of research and strategic projects

A separate report summarizes funding for scientific research for the last few years. Strategic projects that were funded by the NCU during the last three years are NordicNect, UICC/IARC Summer School, NORDCAN and the Nordic Summer School in Cancer Epidemiology. An overview table of funded strategic projects is to be found on the website and should always be up to date.

#### Revision of Statutes

The NCU statutes were revised and considerable changes were made. These changes reflected the need perceived by the NCU Board to make the statutes less rigid and prescriptive and to bring them more in line with what had become the practice of the Board. Guidelines for the application of strategic funds were also revised mainly with the aim of making requirements more clear and thus prevent applications that are not consistent with the core values of the NCU.

#### Adherence to strategy

A strategy for the years 2015-2017 was adopted by the board that delineated five main points and implementation approaches for each point. In reviewing the strategy by the end of the chairmanship it was concluded by the board that the strategy had served as general guidelines for the work of the board and that the process of developing it had clarified what should be the main emphases for the work ahead. As such, the strategy was helpful based on this experience; however, in developing the strategy for the next three year chairmanship, a more flexible approach should be adopted.

#### Accounts and finances

The funding of the activities of the NCU has remained unchanged during the three year period.

Funding of research proposals has been 750.000 euros a year, and the amount available for strategic projects has been 250.000 euros, although the total sum for funding such projects has

been considerably less. Surplus has been used to lower the contribution to the budget by the

member leagues in the following fiscal year.

The amount dedicated to cover the activities of both secretariats (32.500euros each) other

costs has fluctuated between 90.000 to 94.00 euros, and has remained stable.

Revision of processes and procedures

The NCU is a network of the member organizations in the third sector and as such benefits

from the ability to react quickly and informally. However, the Board wanted a more formal

structure and organization in the processes s and procedures of regular work, and thus a

consistent structure of preparing meetings well in advance with well-prepared documents

was emphasized.

Continuity

The Icelandic Cancer Society and the chairman and the coordinator of the NCU for the last

three years are grateful for the support and thoughtful collaboration of the member countries

during the last few years. We would also like to express our gratitude for the generosity of the

other members, which have accommodated some meetings held by the Board, as travelling to

Iceland can be time consuming.

Continuity of the work of the NCU is secured by a well prepared handing over of

responsibilities of the chairmanship and the secretariat to the Danish Cancer Society, which

has developed a plan of action for the next three years.
